Sheltering Emergency Response in Sud (SERIS): is a program to support participatory emergency shelter and hygiene activities, laying the groundwork for community-based Disaster Risk Reduction (DRR) programming in the recovery field in the wake of Hurricane Matthew in Haiti. WCDO distributed shelter fixing kits, along with plastic sheeting distribution, and trained beneficiaries in the St. Jean de Sud and Port Salut areas on techniques for safe shelter construction using these materials. Mobilization of local volunteers, in collaboration with local civil protection committees, ensured equal access. WCDO also collaborated with health and Water, Sanitation, and Hygiene (WASH) actors to conduct door-to-door hygiene awareness campaigns to mitigate the threats of cholera and waterborne diseases in temporary living
